



**Colorado Independent Ethics Commission**

**Case number 12-07**

**Report of H. Ellis Armistead**

April 22, 2013

I was contacted by First Assistant Attorney General Lisa Brenner Freimann and requested to conduct an independent investigation into allegations made by Colorado Ethics Watch regarding the conduct of Secretary of State Scott Gessler. I am not a lawyer and cannot offer legal opinions, and the results of this investigation are only factual.

I was given this investigation with the instructions to investigate the allegations as I saw fit. No input was received nor has anyone sought to have input into the investigative process.

The allegations generally were that Secretary Gessler used state funds from his discretionary account for political activities. Most, if not all, of the facts of this case are uncontested.

It is alleged that Secretary Gessler:

1. Attended the Republican National Lawyers Association National Elections Seminar in Sarasota, Florida on August 24 and 25, 2012, using state funds.
2. Attended the Republican National Convention in Tampa, Florida the week of August 26-30, 2012, using state funds.

3. Used state funds to buy a replacement plane ticket so he could come home early from the Republican National Convention.
4. Received two payments for \$8.99 and \$109.00 labeled "official functions discretionary funds" on July 9, 2012, and the entries appeared to have been reversed on July 27, 2012, and re-characterized as "employee non-cash incentives" with no named employee.

Outside of the complaint, I also looked into the issue of the ADT Security System at Secretary Gessler's home. It appears that the ADT System was reactivated on August 30, 2012, and continues to this day at a cost of \$40.49, per month. These funds appear, according to the documentation, to be paid out of the Secretary's discretionary account.

### **Investigation**

In the course of this investigation I have examined numerous documents provided by Secretary Gessler's attorneys and the previous investigator, as well as documents that I requested from the Secretary of State and Colorado Ethics Watch. On March 28, 2013, I interviewed Chief Administrative Officer Gary Zimmerman, Deputy Secretary of State Suzanne Staiert, and former Deputy Secretary of State, Bill Hobbs. (Attachment 1)

Through his attorney, Patrick Ridley, Secretary Gessler declined to be interviewed for this investigation.

I have also had contact with the other lawyers representing Secretary Gessler; David Lane and Robert Bruce, as well as Luis Toro, director of Colorado Ethics Watch.

I will address the allegations in the order that I previously outlined.

### Attendance at the Republican National Lawyers Association Meeting

The investigation revealed that Secretary Gessler did attend and was a speaker at the Republican National Lawyers Association National Election Seminar in Sarasota, Florida on August 24<sup>th</sup> to 25<sup>th</sup>. The plane ticket and his expenses were paid out of the discretionary fund allotted annually to the Secretary of State in the amount of \$5,000.00. The total amount paid out of the discretionary fund for his attendance at the Republican National Lawyers Association meeting was \$1278.90. The plane ticket was \$498.78. (Attachment 2)

I noted that in requesting reimbursement for these expenses, as well as some others, the Secretary, on September 6, 2012, in a letter to Ms. Lizotte indicated, "These expenses were incurred while meeting with constituents, county clerks, lobbyists' staff and legislators to discuss state business."

I have also reviewed the notebook from the conference. I noted that Secretary Gessler received CLE's as a result of his attendance at the conference.

I requested further information from the RNLA and received a response indicating that Secretary Gessler was not a member of the RNLA at the time he spoke at the RNLA National Election Seminar in August of 2012. Secretary Gessler was formally a member of RNLA up until 2006. The response states that the RNLA seminars are generally open to all attorneys regardless of party affiliation and indicates that members are required to agree with the RNLA Mission Statement. (Attachment 3)

The Mission Statement of the RNLA is included with this report. (Attachment 4)  
The application for membership is included in this report. (Attachment 5) I noted that at the bottom of the application there is a box to check indicating, "I agree with the RNLA Mission Statement."

I noted that in a promotional flier that Lee Rudofsky, Deputy General Counsel for Romney for President, Inc. was a special guest at the closing reception. (Attachment 6)

#### Attendance at the Republican National Convention

It appears that Secretary Gessler did attend the Republican National Convention in Tampa, Florida, and his expenses were paid from his campaign funds, with the exception of his plane ticket. The cost of his plane ticket to Tampa does not appear to have been prorated between the Republican National Lawyers Association meeting and his attendance at the Republican National Convention. This ticket was paid for entirely from the discretionary fund. The cost of this ticket was \$498.78. (Attachment 7)

#### Purchase of ticket to return to Denver early

It is clear that a ticket in the amount of \$422.00 was purchased so that Secretary Gessler could return to Colorado early, allegedly because of threats made against him and his family. These threats were documented and at least one of them was investigated by the Colorado Bureau of Investigation and the Colorado State Patrol. Reimbursement for this trip was made from the operating budget of the Secretary of State. In interviews with the Secretary's staff, I learned it was a unanimous decision on their part to have the Secretary return home early because of the threats. (Attachment 7)

#### July 9<sup>th</sup>, 2012 payments

In interviews with the Secretary's staff I learned that staff advised the Secretary to submit these expense items for incidental expenses he had incurred, but for which he had not sought reimbursement. I was told that these funds were not used for personal

gain. I was told by staff that these funds were used for incidental expenses incurred in the performance of his duties as the Secretary of State. (Attachment 8)

### Alarm System

According to staff, the alarm system was activated after the threats were made to Secretary Gessler and his family. (Attachment 9)

### The Discretionary Fund

In reviewing the documents and interviewing witnesses it appears the discretionary fund allotted to certain state officials and in this particular case, the Colorado Secretary of State's Office, has been used for various purposes by former Secretaries of State. Those uses include, but are not limited to, cocktail receptions for county clerks, personal clothing, overseas travel, etc. There appears to have been no real accounting of these funds and there is not a history of receipts being submitted for expenses incurred and charged against the discretionary fund. One Secretary of State allegedly took the entire \$5,000 as W-2 income while other Secretaries of State have expensed their items.

There appears to be a history of no real control over the discretionary fund, no procedures for vouchers and/or receipts and no specific direction as to how the discretionary fund is to be used as directed by CRS § 24-9-105(1) (d) for expenditures pursuant to official business as each elected official sees fit.

I noted that in many of Secretary Gessler's requests for reimbursement, he included receipts, while in some cases the requests were submitted using memos.

It should be noted that in interviews with Secretary of State's staff it appears that attempts are being made to put policies and procedures in place with respect to the use of discretionary funds.

### Conclusion

This report only reflects the facts regarding the allegations made against Secretary Gessler. It is not a legal opinion and no conclusions are drawn as to the propriety of the Secretary's activities.

I reserve the right to amend this report should more information become available to me.

# ATTACHMENT 1

## March 28, 2013 Interviews

On March 28, 2013, I meet with Gary Zimmerman, Bill Hobbs, and Suzanne Staiert at the Secretary of State's office located at 1700 Broadway Street, Suite 200, Denver, CO. Also present were specially appointed Deputy Attorneys General David Lane and Robert Bruce. Lane and Bruce did not participate in the interview process.

The purpose of this meeting was to interview the above named people regarding their understanding of the discretionary fund and the allegations that have been made against Secretary of State Scott Gessler.

The first person I interviewed was Gary Zimmerman, who is the Chief of Staff to the Secretary of State.

Zimmerman told me that as Chief of Staff, he is responsible for the day-to-day operations of the Secretary of State's office. He said that Suzanne Staiert is responsible for the policy unit and legal matters.

Zimmerman stated that he interacts frequently with Secretary of State Gessler. He said that he was interviewed for his job by Gessler and began on March 7<sup>th</sup>, 2011. He said that it is a "state certified" position.

Zimmerman stated that with regards to the discretionary funds, it was his understanding that they could be used at the sole discretion of the Secretary of State for the benefit of the state of Colorado.

I asked Zimmerman about the history of the use of the discretionary funds and he described it as being "all over the board." He said that some past Secretaries of State have taken lump sums from the discretionary funds. Others have used the funds to purchase clothing, update the furniture in the office, purchase Christmas gifts, give parties, attend international charity events or golf tournaments or have lunches with legislators.

I asked Zimmerman about the Republican National Lawyers Association meeting in Sarasota, Florida in August of 2012 and he characterized that meeting as a CLE (Continuing Legal Education) activity. He said that previous Secretaries of State have used the discretionary fund for educational activities. He stated that one Secretary of State traveled internationally to see how offices in other countries work.

Zimmerman emphasized that all of Secretary Gessler's draws from the discretionary fund were taken as expenses and not as taxable income. He was unaware of any personal use of state funds by Secretary Gessler.

Zimmerman stated that Secretary Gessler lives across from Cheesman Park in a high traffic area. When the threats against him and his family were made, he and Suzanne Staiert took those threats seriously.

Zimmerman explained that when Secretary Gessler took office, he took a pay cut. As part of reducing his household expenses, he suspended his security system.

Zimmerman said that at his request, the CBI and the State Patrol became involved in the investigation of the threats and CBI conducted a security audit of his home. He said that they suggested certain protective measures, such as lighting and privacy screens. Sometime between the first threat and the second threat, he believes Secretary Gessler reactivated the security system. Zimmerman stated it is his opinion that the security system is directly relevant to Secretary Gessler's work as the Secretary of State.

Zimmerman stated that at the end of the 2011 fiscal year, \$1400.00 was disbursed to Secretary Gessler, who provided a memo requesting reimbursement for certain expenses. Zimmerman stated that he travels around the state with Secretary Gessler and spends a lot of time with him. He is aware of Secretary Gessler's personal habits, and is sure that he spent the money (the \$1400.00 he requested via memo) on state business.

Zimmerman stated that "deeper" into the calendar year, his office asked for clarification from the state controller. The controller told them that the Secretary should underline and provide receipts for funds used from the discretionary fund, and at the very least, provide a memo outlining how the disbursements were made. Zimmerman stated that subsequently at the end of the 2012 fiscal year he told the Secretary that he needed to get the rest of his expenses submitted, and that is when he submitted the memo for the \$117.00.

Zimmerman stated that despite the lack of receipts, he is certain that Secretary Gessler spent that much or more, and that the reimbursements were legitimate.

Zimmerman said he began working on an internal memo in the November-December 2012 time frame to address the issue of disbursements from the discretionary funds. He sought direction from David McDermott, and was advised that the controller does not weigh in on the matter of policy for the Secretary of State.

Zimmerman emphasized that there was no process for disbursement of funds in the statute and that a bare reading of the statute leaves the discretion up to the elected official.

Zimmerman stated that with respect to the plane ticket home from the Republican National Convention, he authorized the purchase of the ticket after discussing the situation with Suzanne Staiert. He characterized it as 100% his decision, although he spoke to Heather Lazotte and Suzanne Staiert prior to directing the Secretary to return to Colorado, and to expense the ticket to the state of Colorado from the Secretary of State's operating budget. Zimmerman said he felt this was an appropriate use of state funds given the seriousness of the threats against Gessler and his family.

I then spoke to William (Bill) Hobbs, who is a former Deputy Secretary of State.

Hobbs explained that he worked for the Secretary of State as a Deputy Secretary of State until February of 2012. He worked for numerous Secretaries of State, including Donetta Davidson, Bernie Buescher, Scott Gessler and others. He estimated he has worked for 5 or 6 Secretaries of State. Hobbs said that he first began working for Donetta Davidson in 1999, when she was appointed Secretary of State after her predecessor died.

Hobbs said that Davidson was familiar with the discretionary fund, because prior to becoming the Clerk of the Court in Arapahoe County, she worked for the Secretary of State as the director of elections. He believed that she worked for the former Secretary of State Natalie Meyer.

Hobbs described the discretionary fund as a "small sum" that the Secretary of State could spend as he saw fit. Hobbs stated that Natalie Meyer may have taken the discretionary fund in a lump sum as additional compensation but he is not sure. He said that Donetta Davidson bought furniture for the office, and she left it at the office.

Hobbs stated that in general, the discretionary fund was used for items that could appear questionable if taken out of the operating budget. He used the example that Davidson typically hosted a bar at the Colorado Clerks Convention each year, and liquor for the bar was bought with money from the discretionary fund. There were other items purchased, such as thank you gifts for employees who were going away. In general, the fund was used for expenses that they felt might be later criticized for if drawn from the operating budget.

Hobbs characterized Meyer's use of the fund as "out on the fringes of what may have been proper."



Hobbs stated that with regards to Secretary Gessler, from his prospective all of the expenses seemed to be proper and were related to his position as the Secretary of State. Hobbs stated that he did not see discretionary funds used for partisan political functions by any of the Secretaries of State and did not see Secretary Gessler use any of the funds for his personal use.

Hobbs stated that he was unsure if receipts were always turned in. He said that some people turned in receipts and some did not.

Hobbs stated that he was unaware about the "cleaning out" of the fund at the end of the fiscal year. However it was the practice of most agencies to spend all of the money that was allotted to them in a fiscal year for the benefit of the taxpayers.

I next interviewed Suzanne Staiert, who is the current Deputy Secretary of State.

Staiert was appointed in February of 2012. She reported that she spends about one-third of her time on policy, one-third of her time on legal oversight and one-third of her time with the title setting board.

Staiert said all of her duties are conducted within the Secretary of State's office and that she has no political function.

Staiert stated that it was her understanding that the discretionary fund was allocated to be used by the Secretary of State as he deemed appropriate. She said that it was her understanding that in the past, the fund had been used for vacations, clothing, additions to income, etc. She said that in the past, much of the money was spent without submitting a receipt and it was handled more like a "per diem."

Staiert stated that in the fall of 2012 there was a discussion about setting up a process for disbursement of funds from the discretionary fund but the draft memo was halted when this complaint was made.

Staiert stated that she was aware of Secretary Gessler's attendance at the RNLA meeting, and she characterized that meeting as being more about the political process as opposed to participation in partisan political activities.

Staiert stated she was aware the Secretary was going to attend the Republican National Convention and knew his expenses for the Republican National Convention would come from campaign funds. She said there were concerns about Amendment 41 and discussions with the Secretary about the \$53.00 dinner limit and not receiving gifts.

Staiert said that she was involved in the discussion about the threats made to Secretary Gessler and his family. The threats were received at the office. She first talked to

Secretary Gessler about it and forwarded him the emailed threat. She talked to officials from the CBI, as well as the Deputy District Attorney, Greg Long, out of the Denver DA's office. Staiert said that at some point during this process, Secretary Gessler had his home security system reconnected.

Staiert stated that on the Thursday of the week Secretary Gessler traveled to Florida, she, along with Chief of Staff Zimmerman, told the Secretary to come home as soon as possible.

On Wednesday of that same week, Staiert said she was approached by a Democratic lawyer, Mark Grueskin, who asked her where Secretary Gessler was. She told him that he was out of state, but was not specific, for security reasons. She said that Grueskin told her that he had read in a newspaper article that Secretary Gessler was in Florida. She said this reinforced her belief that he needed to come back to the state, and she advised Zimmerman that the return ticket should be paid out of the Secretary's operating budget.

Staiert stated that she was not aware of the \$117.00 cash out at the end of fiscal year 2012, but later told the Secretary to go back and pull receipts.

Staiert stated that she is unaware of the Secretary using any state funds for personal or political gain.

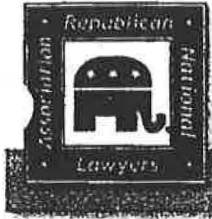
2. RNLA Seminars are generally open to all attorneys regardless of party affiliation. RNLA Members do receive discounted admission to RNLA events.



